Leander and Austin Strong in Market Analyst Update

More than 100 people, mostly business and real estate professionals, gathered at Pat Bryson Hall in Leander on Jun. 11 to hear a market analyst update. Economist Jon Hockenyos (www.txp.com) and real estate strategist Mark Sprague (www.residentialstrategies.com) gave two distinct, highly informative presentations about the state of the economy and answered questions about many hot economic issues impacting consumers and businesses. The purpose of the meeting, organized by the City's Economic Development department and the Greater Leander Chamber, was to gain some perspective on the economy globally, nationally, state-wide, in the Austin area and in Leander. Fortunately, the Greater Austin area (a five county-wide area including Williamson Co.) remain strong. Three key areas, however, emerged from both presentations:

- Easy money has dried up which means a return to normalcy with sound economic principles, equity, good credit, thoughtful plan;
- Relationships are important, business-to-business and business-to-customer time invested is invaluable; and
- Planning is key, this slowdown provides an opportunity to assess your business, and identify weaknesses, areas for improvement and opportunity.
